**Annexure-I Summary of proceedings of 25<sup>th</sup>Annual General Meeting of the shareholders of the Company.**

The 25<sup>th</sup>Annual General Meeting (AGM) of the shareholders of the Company was held on Friday, September 28, 11.30 A.M. at the registered office of the Company at 6/3, Manoramaganj, Indore, M.P.-452001

Mr. Sunil Choksi Chairman of the meeting, introduced his colleagues seated on the dias and welcomed them as well as members of the Company at the said AGM. The requisite quorum being present, the Chairman called the meeting to order. Thereafter with the permission of the members present, the Annual Report for the FY 2017-18, inter-alia containing the Notice of the AGM and the Financial Statements including the Reports of the Directors and Auditors, was taken as read. 
